4. Consumer Law – Misleading Commercial Practices

- Promotional claims about discounts, stock, and being "paid by Facebook" must comply with the **Consumer Protection from Unfair Trading Regulations 2008**.
- The marketing of "mystery bags" with unspecified value or content may be deemed **deceptive**, especially if customers feel misled.

5. Potential for Civil Defamation

• Public accusations of criminal behavior (e.g. bin dumping, dishonesty) without substantiation may open her to **defamation** claims if the subjects are identifiable and harmed.
