#### Legal Breach Report: Carrie-Anne Ridsdale (aka Jayne Price)

**Title:** Alleged Misrepresentation of Qualifications and Use of Protected Titles

## **Executive Summary**

This report presents a consolidated legal overview of alleged offences and regulatory breaches committed by Carrie-Anne Ridsdale, also known as Jayne Price, in her operation of unregistered charities, public health misrepresentation, harassment of critics, and systematic fraud. It is based on verified public records, official statements, surveillance data, and investigative research, including additional information from the expanded public interest investigation, "A Pattern of Deception and Misrepresentation."

The totality of evidence supports a pattern of deliberate misrepresentation across multiple legal, regulatory, and ethical domains. This report outlines applicable UK laws and sentencing for each offence.

# 1. Misuse of the Protected Title "Nurse"

Law: Section 49(1) of the Nursing and Midwifery Order 2001 (SI 2002/253)

**Offence:** Falsely representing oneself as a registered nurse with intent to deceive.

**Details:** - Numerous public statements claiming to be a nurse. - Continued misrepresentation after formal UK Government warning (May 2025).

**Penalty:** - Summary conviction: Unlimited fine. - On indictment: Up to 2 years' imprisonment and/or unlimited fine.

Estimated Sentence: 2 years imprisonment, £10,000+ fine

### 2. Fraud by False Representation

Law: Fraud Act 2006, Section 2

**Offence:** Dishonestly making false representation for gain.

**Details:** - False academic and professional claims used to solicit donations and social credibility. - Misrepresentation to public donors, councils, and service users.

Penalty: - Maximum: 10 years imprisonment, unlimited fine.

Estimated Sentence: 5-7 years imprisonment, £50,000+ fine or restitution

# 3. Charity Law Violations

Law: Charities Act 2011, Trustee Act 2000

**Offences:** Mismanagement in administration of a charity; operating as a charity while unregistered.

**Details:** - Multiple unregistered charity shops trading publicly. - Misuse of "charity" status in official food business applications.

Penalty: - Disqualification from trusteeship (up to 15 years) - Repayment orders for misuse of funds

Estimated Sentence: Civil penalties or disqualification, £10,000+ restitution

## 4. Use of False Academic Qualifications

Law: Education Reform Act 1988, Section 214

**Offence:** Knowingly using a false academic qualification.

**Details:** - Claimed a non-existent "BA Hons Nursing" from Cardiff University. - Used CPD attendance

certificates to falsely claim nurse training.

Penalty: - Summary conviction: Unlimited fine.

Estimated Sentence: £5,000+ fine

### 5. Misrepresentation of Data Protection Qualifications

Law: UK GDPR / Data Protection Act 2018

**Offence:** Falsely claiming authority or training under data protection law.

Details: - Publicly claimed GDPR and safeguarding training without evidence. - Unlawful exposure of

personal data and defamatory publishing.

Penalty: - Civil penalty from ICO (up to £17.5m or 4% of turnover)

Estimated Sentence: £5,000+ fine (if applicable)

#### 6. Online Harassment / Communications Offences

Law: Malicious Communications Act 1988 / Communications Act 2003 (s.127)

**Offence:** Sending offensive, threatening, or abusive messages online.

**Details:** - Public abuse of critics, livestreamed personal attacks, targeting of elderly individuals.

**Penalty:** - Up to 2 years imprisonment

Estimated Sentence: 2 years imprisonment, £5,000+ fine

## 7. Safeguarding and DBS-Related Offences

Law: Safeguarding Vulnerable Groups Act 2006

Offence: Engaging in regulated activity with children or vulnerable persons without proper vetting.

**Details:** - Unregulated contact with mothers, children, and disabled individuals via baby bank services. - No verified enhanced DBS check.

**Penalty:** - Up to 5 years' imprisonment

Estimated Sentence: 3-5 years imprisonment, possible barring from regulated activity

## 8. Consumer Protection / Unfair Trading

Law: Consumer Protection from Unfair Trading Regulations 2008 (CPRs)

Offence: Engaging in misleading commercial practices.

**Details:** - Advertising free items while charging for access. - False claims of authority and partnerships (e.g. FareShare, Foodbank, FCA).

Penalty: - Up to 2 years' imprisonment and/or unlimited fine

Estimated Sentence: 1-2 years imprisonment, £5,000+ fine

# 9. Unlawful Use of Mobility Vehicle

**Context:** - Operates extensive businesses while receiving mobility benefits. - Drives a brand-new 2023 Nissan LEAF Tekna (Reg: CK73 MPF) under Motability scheme despite alleged disability and public benefit claims.

Potential Law: Social Security Administration Act 1992 / Fraud Act 2006

Penalty: - Repossession of vehicle - Ban from scheme - Up to 3-7 years' imprisonment for benefit fraud

Estimated Sentence: £10,000+ liability, 3 years imprisonment (if prosecuted)

## 10. Public Safety and Medical Impersonation Offences

Law: Human Medicines Regulations 2012 / Offences Against the Person Act 1861

**Offence:** Distribution of controlled substances (Naloxone) without authorisation; impersonation of healthcare professionals.

**Details:** - Publicly offered naloxone training without qualification. - Misrepresented as being trained in chemotherapy, cancer care, and midwifery.

**Penalty:** - Up to 2 years imprisonment and regulatory enforcement

Estimated Sentence: 1–2 years imprisonment, civil or criminal sanctions
